- 2. Minutes for June and July. Jennifer Nelson requested they be moved to next meeting.
- 3. Update from Pool Manager, Hannah Torres

Discussion

- CGSRC Board asked Hannah Torres to check if lifeguards would be available to work on Friday, August 31 so Club could be open on the Friday before Labor Day.
- Hannah informed Board that lifeguards are not available to work on Friday evenings in September, other than the parties they have already agreed to work. To incentive lifeguards to work on Fridays, Board agreed to buy dinner for the guards that work those evenings.
- Club policy regarding no call-no show discipline process will be addressed in 2019.
- Hannah asked if lifeguard would be paid double time for working kids camp out. She shared that was the way it was handled in the past. Board agreed that lifeguards who work from normal closing hour through the night/early morning will be paid double time.
- 4. 2019 schedule Fridays in August and September Discussion and Vote Ryan Petta made motion for Club to be open on Fridays in August and September 2019. Seconded by Jeff Taylor. Unanimous.

- Swim team amount payable to CGSRC includes lifeguard costs at meet, consumables, and non-members who were on team. Swim Team has already paid the PG&E reimbursement.
- 6. Operations Discussion
- Sidewalk repair: Brian Stoddard will get quotes expects it will be around \$5,000; City offered to fix for \$7,000. Goal is to fix in September time frame as it will take a week to get it completed.
- Ivy tree/trimming: Due to the high cost, Brian Stoddard will get a second bid over the next month. Board agreed to remove the dead tree on Citadel.
- Drinking water fountain/dispenser: Brian Stoddard is comparing prices for a filtered, refrigerated water bottle filler/drinking fountain models.
- Mural replacement: The wood is rotted and will be torn down on workday. When put up replacement, Brian will make it taller to eliminate basketballs flying over the top.
- Workday October 7: Items include remove ivy, tear down mural/put up new wood/weather proof.
